## A. Institution: Annual membership fee for institutions

The annual membership fee for the "institutions" is

- Dance school, company, club, dance sports department, individual club, etc: annual **110,00 €**
- Associations **annually by appointment**

The membership fee is collected at the beginning of **each** calendar year **after prior invoicing**. For new members, it is due immediately upon **confirmation** of membership.

From **1. September** ~~October~~ each year we offer a reduced annual membership fee for new members for the current calendar year: **80,00 €**

Individual members admitted by decision of the Presidium may be exempt from contributions. Founding members and honorary chairmen/honorary presidents as individuals are free of charge.

## Licenses

### Competition License Fee

The list of the license fee will be sent to the organizer at the end of the deadline. The amount is staggered based on the number of reports. If the competition does not take place due to the fault of the organizer, the competition license in the amount of the sum of the comparable competition of the previous year is still due and will be confiscated at the time of cancellation.

Competition licenses are valid per competition day/weekend for all regional and open competitions, area championships/championships/cups.

If events are divided by location or time (**non-consecutive days**), they are counted as two or more competitions. If a competition takes place over two or more days on a weekend, the licence fee is valid for all days.

Cost per competition with

- up to 50 starts **25,00 €**
- up to 100 starts **50,00 €**
- up to 250 starts **75,00 €**
- up to 500 starts **150,00 €**
- up to 750 starts **300,00 €**
- up to 1,000 starts **450,00 €**
- More than 1,000 launches **550,00 €**
- Hobby competitions (related to a TAF competition) **100,00 €**

## B. DANCER

### Dancer Annual Licenses

Each institution pays a one-time annual fee (annual dance license) for its dancers per person, per calendar year, in the amount of **20,00 €**

(Note on TAF-TJL: If you start for several institutions, the TJL is due for each institution.)

This fee is due by direct debit for the registering institution at the first start of the competition of each calendar year. Calculated dancer annual license fees are non-refundable.

#### **Exception: West Coast Swing:**

In this case, annual dancer licenses are not required (if no online registration is offered via the TAF member area)

### Entry (Start) fees

All dancers must be registered via [www.taf-germany.de](http://www.taf-germany.de) via online registration in the members' area by the specified 1st or 2nd deadline.

The entry fee due

- is per person and start **15,00 €**
  - Exception** in den Performing Arts Disziplins:
    - Duo** (per Person): **20,00 €**
    - Solo:** **25,00 €**
- will be debited from the account of the institutions by direct debit at the end of the deadlines with proof of names (*exception for hobby competitions: TAF does not charge entry fees here*).

A later registration is only possible if the organizer and TAF extend the registration deadline (2nd deadline). In this case, the entry fee is doubled.

For late registrations on the day of the event, the entry fees will also be doubled (should the organizer and TAF accept these registrations).

Calculated entry fees will not be refunded.

The registration of the dancers can usually only be done until the end of the 2nd deadline (sometimes this is identical to the 1st deadline). The following deadline regulation applies

- A) Anyone who wants to until the 1st deadline , the Simple entry fee.
- B) If you cancel your registration by the 1st deadline, you do not pay an entry fee.
- C) If you register by the 1st deadline and cancel between the 1st deadline and the 2nd deadline, you pay the simple entry fee.

- D) If you register between the 1st deadline and the 2nd deadline, you pay double Entry fee.
- E) If you register between the 1st deadline and the 2nd deadline and cancel after the 2nd deadline, you pay also double the entry fee (i.e. he does not get the entry fee waived as in case "B").

### **Ausnahme West Coast Swing:**

There are staggered entry fees for registrations on site:

- 1. Start per event: 30,-- ~~20,--~~ €
- Every further start at this event: 15,-- ~~10,--~~ €

- For online registrations via the TAF member area 15,-- ~~10,--~~ €
- Every further start at this event: 15,-- ~~10,--~~ €

## **C. Judge / Supervisor / Scrutineer**

### **License Acquisition Training**

- One-day training 50,00 €
- Weekend training 100,00 €

### **Training License Acquisition**

- One-day training 25,00 €
- Weekend training 50,00 €

- Judges' licence (book) national** 10,00 €

## **D. Direct debit collection / distribution of entry fees**

All amounts will be debited promptly after the invoice/statement has been sent to the TAF institution.

Please make sure that the account for the direct debits has sufficient funds.

In the case of a chargeback caused by an institution, it is automatically blocked with all messages.

This blocking can only be reversed if the full fees including the costs for the chargebacks, other bank fees and processing fees have been received in the TAF account.

### **Late registrations**

Direct debit collection after the end of the competition

TAF will collect the entry and license fees collected by the organizer on site for the approved late registrations by direct debit from the organizer's account shortly after the competition.

25% of the entry fees remain with TAF, 75% go to the organizer (These will be automatically transferred to the organizer after the deadline.)

## E. Reimbursement

### F. Arrears

Reminder: 9,-€  
Includes chargeback fee and processing fee with deadline

Warning: 15,- €  
Additionally with deadline setting.

In case of non-payment, the respective institution will be deactivated.  
Deactivation does not release you from the obligation to pay the items that are still open.  
In the event of reactivation, the open items incurred so far must be paid in advance.
